

## **Inter-rater Reliability Opportunities**

### **Integrated Education Services: Erie 2-Chautauqua-Cattaraugus BOCES**

#### **Inter-rater Agreement**

This is defined as when reliable raters agree with each other about the exact ratings to be awarded. Participants will focus on alignment within Domains 2 & 3 for Danielson Rubric and Standards 3 & 4 for the NYSUT rubric by collecting evidence around video classrooms. In addition to inter-rater agreement among participants, action planning and next steps with the video teacher will be discussed as a model for district implementation.

#### **Inter-rater Reliability**

This is defined as when reliable raters agree with the "official" rating of a performance. As part of a Video Scoring Project in collaboration with other BOCES across NYS, "true scores" have been determined for a series of videos that cross grade levels and content areas. Additionally, artifacts of teaching practice were also developed which will enable us to provide inter-rater reliability opportunities at a variety levels depending on the needs of the principal/district. This work is "onsite" only or as scheduled by districts and will be limited to a certain number of districts due to the video use and time required. Please schedule with Theresa Gray, Coordinator.

#### **Option 1:**

Participants will focus on Domains 2&3 for Danielson Rubric and Standards 3 & 4 for the NYSUT rubric. Districts will receive the videos to be used with a window for viewing and collecting evidence. Individual participants will be provided with an evidence and alignment document (Google Doc) which will need to be completed by the review date. Calibrated reviewers from the IES team will review and provide feedback on what is submitted. Individual (1 hour) or team video conferences may be held as a follow-up once the feedback is received.

**Dates:** As scheduled or by the quarterly regional review dates.

**Cost:** \$250 for admin teams (up to 5 members), \$25 each additional member OR 1 ½ Coser 565 or RTTT:APPR days

#### **Option 2:**

Participants will focus on all Domains for Danielson Rubric and Standards 1-5 and 7 for NYSUT using both videos and artifacts of teacher practice including pre-post conferences, samples of student work and lesson plans. Videos will be sent for viewing and collection of evidence within a two-week window and artifacts will be sent for annotation. Individual participants will be provided with an evidence and alignment document (Google Doc) which will need to be completed by the review date. Calibrated reviewers from the IES team will review and provide feedback on what is submitted. Individual (1 hour) or team video conferences may be held as a follow-up.
