## **Test Integrity**

- Computer based testing in 2014-2015
- Capacity/needs assessment to be done
- Pilot in 2012-2013
- Additional forensics on assessments will be done
- Erasure analysis and wrong-answer analysis for 10% of assessments
- Additional inter-rater reliability studies
- Increased retention of answer sheets for investigative purposes
- Local monitoring
- Recommendations to come in November
- Beginning in 2012-2013: teachers prohibited from scoring their own exams

## **Appeal Process for Local Diplomas**

### **Local Diploma with Appeal**

Assessment: **3 required Regents exams** with a score of **65 or better** and **2 Regents exams** with a score of **62-64** for which an appeal is granted by the local district per Commissioner's Regulation 100.5(d)(7) as follows: 1 Math, 1 Science, ELA, Global History and Geography, US History and Government

Change brings consistency within the regulations and allows for appeals for General Education students given the changes in the scoring procedures that will result in more scores falling in the 62-64 score range.
